

IMPORTANT NOTICE

2006 Atlantic City International Power Boat Show

Exhibitor Responsibilities:

Exhibitors are responsible to bring their loads/boats to the center and pick up their loads/boats at the close of show. Exhibitor provides trailer and all blocking equipment i.e. blocks, stands, dollies, cradles or rent them from Brownell Systems, Inc.

Show Management Responsibilities:

NMMA's responsibilities are to unload and set boat(s) in the exhibitor's space and reload boat(s) on to trailers at close of show. The staging/marshaling yard is for exhibitors to stage boats while they are transporting others to/from the Center. Transportation of boat(s) to/from Marshaling yard is not the responsibility of show management.

Boats arriving for the AC International Power Boat Show

There are two possible means of transporting your boats for display in the Show.

1. **Over-the-road.** Boats that are not restricted by height from over-the-road travel **MUST** either be brought directly to the AC Convention Center on your targeted move-in date & time OR (for early boat staging) they can be stored in the ACIPBS Boat Staging Yard (the Trump Casino & Marina Employee Parking lot). The staging yard will be available starting **Friday, January 27, 2006**. The Boat Staging Yard located on the eastbound side of Rt. 30 (White Horse Pike) just before the Penrose Canal Causeway.
2. **By Water.** There are strict criteria for boats coming by water (listed below). It is not a matter of simple convenience, the boat hauling services provided by the Show are meant solely for those vessels that **CANNOT** be transported over-the-road due to height restrictions (max loaded height 14'-6"). This is with ALL masts, hardtops and fly-bridges removed. Only boats that exceed the over-the-road height restrictions when the aforementioned have been removed will be hauled/splashed at the A.C. Wescoat Yacht Yard.

ALL exhibitors will receive a specific move in date & time by January 13, 2006.

Boats arriving by water criteria:

- Boats must exceed 37' LOA
- Must exceed over-the-road height restrictions (max loaded height 14'-6") when bridges, hardtops and/or masts are removed.
- Boats coming by water must be pre-approved by the NMMA.
- Boats cannot exceed 61 feet in LOA, 20 feet in height measurements are from the bottom of the rudder to the top of the boat, including towers and radar equipment and 66,000 gross pounds without first being pre-approved by the NMMA. Fax request to Jon Pritko @ 212-564-2728
- Boat information & layout diagram have been submitted to NMMA by December 16, 2005.
- Boat Information form must note that the boat will be arriving by water.
- Exhibitor must notify NMMA of any special handling needs (i.e., extra bridge, hardtop or mast work).
- Boats must arrive one hour prior their designated move-in time.
- Exhibitor is on hand to supervise boat hauling and placement onto trailer at the A.C. Wescoat Yard and at the exhibit space inside the Atlantic City Convention Center.
- Boats must be accompanied by the proper weight bearing dollies or jack stands to avoid any possible delays. The Show does not have any dollies or jack stands for rent. Exhibitors must supply their own equipment or purchase them from Brownell Systems, Inc.
- Any boat or exhibitor who does not meet the above requirements may not be handled or hauled and could be turned away. Show Management (NMMA) has the final say when deciding on restricting boats that exceed or do not meet any of the requirements mentioned. The decision will be based on feasibility, logistical issues and safety.
